## **Sodium Bicarbonate: Allergens Statement**

The raw materials used to produce Genesis sodium bicarbonate do not contain, nor do we purposely add in processing, any allergen (e.g., no milk or milk products, peanut products, tree nuts, grains, fish or seafood, shellfish, soy, seeds or seed products). Genesis does not add, nor do the raw materials or process contain, any sensitizing agents (e.g., FD&C yellow No. 5 or No. 6) or fragrances. We do not add sulfites, monosodium glutamate or other preservatives/additives. While we do not test for these substances in our final product, knowledge of our starting materials and process lead us to believe that they would not be present.
